### Please Read All Instructions Before Proceeding

- Use this certificate for all mares bred.
- Use this certificate for a single mare only. In the event of substituting another mare a new certificate is required.
- This certificate is to be completed by the mare's owner and/or licensed veterinarian. Please print legibly or type.
- Prior to the first insemination, the licensed veterinarian must review the Identification page and sign that the mare being inseminated matches the identification given.
- The breeding record must be signed on every occasion that the mare is inseminated and at each examination following insemination. It must be signed by the attending veterinarian after examining the mare 60 to 65 days after the last day bred.
- This certificate **MUST** be returned at the conclusion of the breeding season in which it is issued. ***The return is required whether the mare becomes pregnant or not. Failure to return this certificate at the end of the breeding season will negate your contract.***
